I. SETTLEMENT EXTENSION

The Parties have requested a third ninety-day extension of the period of time for issuing a decision so as to enable them to pursue settlement. The request was timely filed and was stipulated to by all the parties.

The Parties indicate that Snohomish County, by Amended Ordinance 09-079, adopted May 12, 2010, established a process for negotiating an interlocal agreement concerning development of the area in dispute. The parties request time for such negotiation, as it may resolve the issues in this matter.

In accordance with the terms of RCW 36.70A.300(2) the period of time for issuing a decision is extended for a period of ninety (90) days for the purpose of exploring settlement.


Pursuant to this extension, the new deadline for a Final Decision and Order is **February 6, 2011**. The parties must be prepared to proceed regarding the issues in this case according to the following schedule or file a joint motion for an extension or dismissal no later than **September 1, 2010**.
